Everyone can do something!


Anyone can do prison ministry!

What is Restorative Justice?

- Restorative Justice is a concept of justice that involves the victim, the offender, and the community coming together in a healing process.
- Globally, restorative justice practices can be viewed as an alternative to incarceration and revenge, enabling all parties to communicate, attempt to understand what has happened, and proceed with healing and restoration.

Did you know?

- The USA has 5% of the world's population, but 25% of the world's prisoners.
- In 2009, Pennsylvania was rated #1 in the United States for prison growth.
- An average of 1200 persons are currently in the Lancaster County Prison each week, of which 78% are detainees awaiting court action, and 55% have committed less serious, non-violent offenses.
- At least 1300 minor children in Lancaster Country have incarcerated parents.
- *All* children are negatively affected by limited or no contact with their incarcerated parent(s). Many children are plagued with shame, guilt, and anger.
